1. Purpose

Community Shelter Board (CSB) is seeking proposals in response to the Continuum of Care Supplemental Notice of Funding Opportunity to Address Unsheltered Homelessness, (Continuum of Care Supplemental to Address Unsheltered and Rural Homelessness (hud.gov))

Applicants can apply to provide:

- Permanent Housing
 - o Rapid Rehousing
 - Permanent Supportive Housing (costs for acquisition, new construction or rehab are not allowable)
- Joint Transitional Housing and PH-Rapid Rehousing
- Supportive services only (includes projects providing services to unsheltered)
 - Street Outreach
 - Coordinated Entry
- HMIS
- CoC Planning (limited at 3% of the application)
- CoC UFA (limited at 3% of the application)

2. Target Population

Programs will serve unsheltered individuals and families and individuals and families with severe service needs.

3. Qualifications and Performance

CSB is seeking proposals that will demonstrate the ability to create a sustainable program that will achieve all expected outcomes. Review the expected outcomes by project type:

Applicants should have experience with providing some or all of the services the target population described above needs. Applicants are expected to implement programs that comply with <u>CSB</u> <u>Partner Agency Standards</u> and the <u>Homeless Crisis Response System Policies and Procedures.</u>

4. Contract Amount and Terms

Maximum award for Columbus and Franklin County: \$9,123,297 (over 3 years)

Grant term: 3 years, renewable

Grant start date: July 1, 2023

Match requirement: 25% and in some cases 50%, please see the Attachments section of the Application, by program type

Applicants should apply for the amount of funding that can reasonably be spent for the 1st grant term of July 1, 2023 – June 30, 2026.

Review Criteria

Proposals will be reviewed based on the following:

- Administrative Capacity: Does the applicant have the capacity to comply with <u>CSB Partner Agency Standards</u> and the <u>Homeless Crisis Response System Policies and Procedures</u>? Does the applicant demonstrate the experience and capacity to achieve the goals and objectives described in the RFP and the Continuum of Care Supplemental Notice of Funding Opportunity to Address Unsheltered Homelessness?
- Application Completeness: Is the RFP responsive? Is the application complete?
- Program Design: To what extent is the project design is clear, reasonable, and consistent
 with the RFP and Continuum of Care Supplemental Notice of Funding Opportunity to
 Address Unsheltered Homelessness requirements? Does the applicant adequately
 describe the project?
- Equity Factors: Did the applicant implemented or is working to implement equity-related policies at all levels of the organization?
- Cost Efficiency: Is the requested budget reasonable? Are project costs adequately explained, reasonable and eligible? To what extent does the project leverage other community and CSB investments and is responsive to the match requirements?
